

Terms of Registration for Deeper Life @ SBC Programs and Events:

1. I hereby give permission for to be photographed during Deeper Life @ SBC (herein called DL@SBC) programs or events. I understand that the photos will be used to keep a journal of activities, to share during presentations and for promotional purposes. I understand that although the photographs may be used for advertising, my identity will not be disclosed. I do not expect compensation and agree that all photos are the property of DL@SBC.
2. I hereby give permission to be transported for official DL@SBC activities by modes of transportation agreed to by the ministry organizers and only by those authorized to do so.
3. I hereby give consent for participation at DL@SBC and all related activities. I understand that the programming includes physical activity in the form of a variety of sports and recreational activities. I agree that DL@SBC will not be held liable for any injury, or loss or damage to personal property. In consideration of being allowed to participate in the ministry, I waive all present and future claims against DL@SBC and its directors, volunteers, employees, officers, servants, representatives, insurers and agents (and their respective successors and assigns - collectively, the "Releasees") and hereby release the Releasees from and against all liabilities, claims, actions, demands, costs and expenses relating to injury, illness, death, loss, damage to person or property or loss of property, foreseen or unforeseen, howsoever caused, arising out of or in connection with participation at DL@SBC.
4. In the case that I cannot respond in an emergency, I hereby give permission to licensed emergency and health care personnel to provide treatment, services and transport necessary to maintain my health. In the event medication, medical advice, treatment and/or equipment are required, I agree to accept financial responsibility for fees in excess of provincial and or private medical insurance. I agree that my information on my application may be disclosed to such emergency and health care personnel. In the event of illness, accident, emergency, or any other circumstance requiring medical treatment, such treatment may be procured for the participant without legal or financial obligation to DL@SBC. All known health issues have been stated to DL@SBC. I will notify DL@SBC if I am exposed to any infectious diseases prior to arriving at the facility.
5. Myself, or my family, will not enter the facility or property of DL@SBC if anyone in my household shows signs of any contagious illness, is sick with cold-like symptoms (cough, fever, runny nose, sore throat, or shortness of breath) not related to a known pre-existing condition, has been in contact with a confirmed case of COVID-19 in the past 14 days, or has been out of the country 14 days before the program/visit. I agree that we may be asked to do daily self-checks while attending DL@SBC programs or events. I understand that there is a risk of exposure to any virus while we attend the facility and/or programming, in spite of the precautions that have been taken by DL@SBC in following directions outlined by local health authorities to try to limit exposure to the COVID-19 virus or to other communicable diseases. I further understand if I have a pre-existing condition, it may make them more vulnerable to a virus.
6. In the event of a potential exposure to COVID-19 (or other serious contagious illnesses), DL@SBC will work with Saskatchewan Health Authority (SHA) to contact participants and notify them of the probable exposure. Information about attendees will only be given to SHA if a potential exposure occurs onsite. In the event of a potential exposure to contagious illness at DL@SBC, by agreeing to these terms, I give DL@SBC permission to share my contact information, or my child's, with SHA for the purposes of contact tracing and notification of potential exposure or risk.
7. Furthermore, I agree that I and my child attending will obey all DL@SBC rules and take full responsibility for behavior in addition to any damages caused to the facilities utilized by DL@SBC.

I have read and understood the terms of this agreement and by registering to participate in activities or events at DL@SBC, I am voluntarily agreeing to abide to these terms. I confirm that the participant(s) are physically and mentally able to participate in all activities of the camp, unless specifically indicated otherwise in writing or on the application form
